**Project Background:** CBM Aggregates (CBM), a division of St. Marys Cement Inc. (Canada), is exploring the feasibility of developing a quarry in the vicinity of Charleston Sideroad and Main Street/Regional Road 136 in the Town of Caledon. CBM initially informed the public in November 2019 and then began technical studies in February 2020 to determine the feasibility of future extraction, and to support the required applications that may be filed for municipal and provincial approvals under the *Planning Act* and the *Aggregate Resources Act*. The project is still in the early stages as the technical studies will be completed over a span of approximately two years.
